IN 2014, WE SERVED MORE THAN 18,389 PEOPLE THROUGH THE RONALD MCDONALD HOUSE PROGRAM AND PROVIDED MORE THAN 54,199 OVERNIGHT STAYS FOR FAMILIES WITH SERIOUSLY ILL CHILDREN. IN ADDITION, MORE THAN 98% OF OUR FAMILIES INDICATED THEIR STAY AT A RONALD MCDONALD HOUSE HAD A POSITIVE IMPACT ON THEM AND THEIR CHILD'S RECOVERY AT A LOCAL PEDIATRIC HOSPITAL.**
